Dear Pine Valley Panthers and Community Members,

In preparation for the district-wide Budget Vote and Board of Education election on June 9, 2020, we present this year's District Budget Newsletter. In addition to these pages, the full detail of this year's budget as presented on May 28, 2020 at the Budget Hearing is available on our website at www.pval.org.

This year's budget has evolved since January due to exhaustive analysis by the administrative team and Board of Education, and the ever- changing situation with COVID 19. Every line item has been analyzed to ensure fiscal responsibility to you, our taxpayers, long-term sustainability for the district, and student-focused programming. This year we are proposing a tax increase of 1%. This modest increase would have a \$7.02 annual impact on those with a \$100,000 house. Due to future uncertainty in revenue from the state, it is necessary to secure as much stable funding as possible and to be fiscally conservative.

The proposed 2020-2021 budget is \$1.3 million less than this year's budget. It includes more programming in house for students, a new English Language Arts program in K-6, and a school- wide writing program to improve student achievement. We ask that you please vote via your absentee ballot.

We understand that this is a difficult time for all of our families and taxpayers. Please know that we take our responsibility to the taxpayers seriously. In every decision, we work hard to balance our responsibility to our taxpayers with our responsibility to provide an excellent education to the children of this community. Thank you for your time and attention.

Proposition #1 - Basic Budget \$15,763,272

Shall the budget for the year 2020-2021 as approved by the Board of Education be adopted and the required funds therefore be raised by a tax on the taxable property of the school district?

Proposition #2 – Purchase of Buses/Van Using the District's Transportation Vehicle Reserve Fund

Shall the Board of Education be authorized to purchase two school buses and one van for use in the transportation program of the District at an estimated maximum cost not to exceed \$280,000 and to transfer or apply (during the current fiscal year of the District) up to \$280,000 from the District's Transportation Vehicle Reserve Fund (established in May of 2015) to the District's general fund to pay for such purchases.



The General Support section of the budget covers managerial functions for the entire District including funding for the Board of Education, School Superintendent and financial operations of the district; operations and maintenance of school buildings and grounds, fire and liability insurance coverage, personnel management, legal expenses, public information expenses including related BOCES administrative charges.

<u>Instruction</u> 8,653,370 7,918,047 (735,323) -8.50%

Instruction is the core area of the school budget generally covering salaries for administrators, teachers, aides, clerical staff, school nurses, psychologists, guidance counselors, library media specialist and other essential staff members. This section also covers all materials, supplies and equipment necessary to support the educational needs of our students. Co-curricular and interscholastic athletic activities are also included in the Instruction section of the budget.

Transportation 1,141,786 997,064 (144,722) -12.68%

The district utilizes its own employees to provide transportation services to students for regular transportation within and outside of District boundaries for instructional purposes, co-curricular and interscholastic athletic activities.

Employee Benefits 3,051,022 2,951,976 (99,046) -3.25%

This category consists of a variety of employee benefits including required contributions to the New York State Teachers' Retirement System and Employee Retirement System, Social Security, Workers' Compensation, Unemployment Insurance and Health Insurance benefits.

Debt Service 2,589,844 2,276,913 (312,931) -12.08%

This category contains District-wide costs associated with serial bonds for school construction including costs related to the current water project and debt for school bus purchases.

TOTAL BUDGET 17,140,656 15,763,271 (1,377,385) -8.04%
