Superintendent of Schools 2023-2024 Proposed Budget

Dear Pine Valley Families and Community:

In preparation for the district-wide Budget Vote and Board of Education election on May 16, 2023, we present this year's District Budget Newsletter. In addition to these pages, the full detail of this year's budget, as presented on May 4, 2023, at the Public Hearing, is available on our website at www.pval.org.

This year's budget will allow us to continue to support the ever-changing needs of our students, families, and staff and be responsive to the needs of our students. We will be working to enhance our programming to push student achievement forward. Since the pandemic, we have already seen progress in the areas of English Language Arts and mathematics student achievement. Every line item has been analyzed to ensure fiscal responsibility to you, our taxpayers, long-term sustainability for the district, and student-focused programming. This year we are projecting a tax levy increase of \$101,628.00. We are bringing a 2.98% tax increase at this time. Please note that the school district's aid runs for the upcoming year vary more widely than in previous years. Our aid increase is very modest compared to some. Therefore, you will see much variety across different districts and their proposed tax increases.

The proposed 2023-2024 budget is \$940,083.00 more than last year's budget. Key items included in this coming year's budget include contractual salary increases, the purchase of one electric bus, a new van, our school resource officer, and a health insurance increase of 7%. Please note that in regard to the purchase of an electric bus, currently, the law states schools must prepare to have an entirely electric fleet by 2035. School districts may no longer purchase diesel buses after 2027. In order to be responsive to this law, fiscally responsible to taxpayers, and respectful of our bus rotation schedule, we are proposing the purchase of one bus for the coming year. While we recognize that 2035 is a long way away, we do not want to be unprepared with a district as geographically large as ours. Exhaustive research has been done to prepare for the purchase of one vehicle. This will allow our staff and community exposure to

the technology and any issue that may arise. We will still receive our normal transportation state aid of 90% on this purchase, and this will allow us to move slowly into meeting this legislation.

Most importantly, this budget prioritizes programming for students. Every detail of local, state, and grant allowable expenditures has been scrutinized to maximize the use of these funds and to provide more for our kids. The proposed 2023-2024 budget and the systematic utilization of grant funds will allow for the purchase and implementation of a new English Language Arts program for grades 9-12, which parallels previous years' purchases for 7th and 8th grade. Additionally, our three coach positions which were originally grant-funded in the areas of English Language Arts, Mathematics, and student behavior, will be maintained.

Please know that we take our responsibility to the taxpayers seriously. In the past six years, taxes have only been increased by a combined 3.4%. In every decision, we work hard to balance our responsibility to our taxpayers with our responsibility to provide an excellent education to the children of this community. Thank you for your time.

2023-2024 Budget Propositions

You will be asked to consider the following propositions:

Proposition No. 1: Basic Budget \$18, 547, 777

Shall the following resolutions be adopted?

Shall the budget for the year 2023-2024, as approved by the Board of Education, be adopted, and the required funds, therefore, be raised by a tax on the taxable property of the school district?

Proposition No. 2: Student Representative

Shall the following resolutions be adopted?

Shall a student be selected pursuant to Section 1804(12) of the New York Education Law as an ex officio member of the Board of Education of the Pine Valley Central School District, and that such ex officio member shall be entitled to a) sit with the board members at all public meetings of the board, and b) participate in all board hearings and meetings, but shall not a) have a vote, b) be allowed to attend executive session, or c) be entitled to receive compensation of any form for participating at board meetings, and shall be subject to the further terms and conditions of Section 1804(12) of the Education Law.

Who Can Vote?

You are entitled to vote if you are a U.S. citizen, 18 years or older, and have been a district resident for at least 30 days prior to the vote. No pre-registration is required.

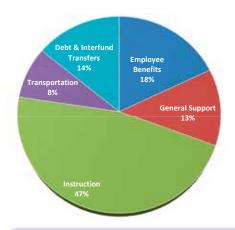
Optical Scan Voting System

We use the Optical Scan Voting System utilizing the services of the Chautauqua County Board of Elections.

Absentee Voting

You may vote by absentee ballot if you are unable to appear at the polling place on May 16, 2023. To receive an absentee ballot, voters must obtain an application from the district office. The application must be returned to the district office at least seven (7) days before the election if the ballot is to be mailed to the voter, or at least one day before the election if the ballot is to be picked up personally by the voter at the district office from 8:00 am to 3:30 pm. Absentee ballots will be counted only if they are returned no later than 5:00 pm on election day. For more information, call Lindsay Anderson, District Clerk, at 988-3293 ext. 3307.

Instruction

The Instructional Program is the largest budget category and the focal point of our educational system. All services that provide or directly affect instruction of students are budgeted in this area. The following are included in this category: regular school, special education, summer school, school libraries, health, psychological and social work services, curriculum coordination and supervision, curriculum development, BOCES instructional programs, interscholastic athletics, and co-curricular activities.

Transportation

Includes transportation services to students for regular transportation within and outside of district boundaries for instructional purposes, co-curricular, and interscholastic athletic activities.

General Support

The General Support section of the budget covers the areas that support the educational program through central administration, business operations, human resources, community relations, maintenance and repair of all district grounds and facilities, printing, mailing, district meetings, Board of Education, and legal services.

Employee Benefits

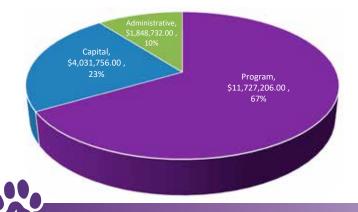
This category consists of various employee benefits, including contributions to the New York State Teachers' Retirement System, New York State Employee Retirement System, Social Security, Workers' Compensation, Unemployment Insurance, and Health Insurance benefits.

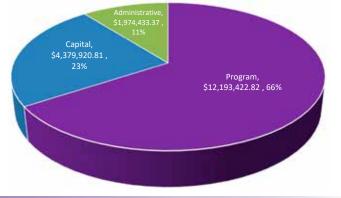
Debt & Interfund Transfers

This category includes short and long term debt payments (funded by Building Aid) and transfers to other funds.

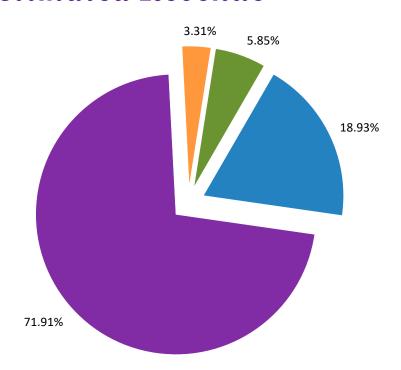

A modest property tax increase of 2.98% is included in the proposed budget. This equates to an approximate tax increase of \$28.34/yr for a homeowner receiving a basic STAR exemption and property with a taxable assessed value of \$100,000. The proposed increase is well below the allowable calculated tax cap of 6.3%.
