Proposition #1 – Basic Budget \$16,437,677

Shall the budget for the year 2021-2022 as approved by the Board of Education be adopted and the required funds therefore be raised by a tax on the taxable property of the school district?

The two following candidates are running for one of the threeat large positions available on the Board of Education. There will be a third candidate, that will be voted upon May 18, 2021 via write-in. (Names are listed in alphabetical order as they will appear on the ballot per Executive Order 202.26)

Dear Pine Valley Panthers and Community Members,

In preparation for the district-wide Budget Vote and Board of Education Election on May 18, 2021, we present this year's District Budget Newsletter. In addition to these pages, the full detail of this year's budget as presented on May 6, 2021 at the Budget Hearing is available on our website at www.pval.org.

This year's budget has evolved since November with each update from the State and Federal levels, a deeper understanding of our evolving district needs, analysis by the administrative team and the Board of Education. Every line item has been analyzed to ensure fiscal responsibility to you, our taxpayers, long-term sustainability for the district, and student-focused programming. This year we are proposing a tax increase of 1%. This increase would have a \$10.65 annual impact on those with a \$100,000 house. Due to future uncertainty in revenue from the state, it is necessary to secure as much stable funding as possible and to be fiscally conservative. However, we do not plan to go to our tax cap this year in order to be respectful to our taxpayers.

The proposed 2021-2022 budget is \$16,437,677. Our budget last year was \$15,763,271. This budget that was \$1.3 million less than previous years. Having already reduced our budget last year and freezing spending this year we have maintained a healthy financial position throughout the pandemic. Our goal is to continue that work and position.

In order to return to a full, normal schedule in both buildings it is important to rehire for some positions that we were able to go without during our revised Covid-19 schedule. The proposed budget includes more programming for students, 4-year old Prekindergarten, 3-year old Prekindergarten, a replacement Special Education Teacher, Teacher's Aide, and a replacement Elementary Art Teacher. Please note both Prekindergarten settings are partially funded by grants.

We ask that you please vote in-person on May 18, in our High School Foyer, outside of the gymnasium. To request an absentee ballot please contact our District Office.



2020-2021 Approved Budget 2021-2022 Proposed Budget



The General Support section of the budget covers managerial functions for the entire District including funding for the Board of Education, School Superintendent and financial operations of the district; operations and maintenance of school buildings and grounds, fire and liability insurance coverage, personnel management, legal expenses, public information expenses including related BOCES administrative charges.

Instruction 7,913,939 8,001,760 87,821 1.11%

Instruction is the core area of the school budget generally covering salaries for administrators, teachers, aides, clerical staff, school nurses, psychologists, guidance counselors, library media specialist and other essential staff members. This section also covers all materials, supplies and equipment necessary to support the educational needs of our students. Co-curricular and interscholastic athletic activities are also included in the Instruction section of the budget.

<u>Transportation</u> 997,064 1,334,449 337,385 33.84%

The district utilizes its own employees to provide transportation services to students for regular transportation within and outside of District boundaries for instructional purposes, co-curricular and interscholastic athletic activities.

Employee Benefits 2,951,976 3,207,371 255,395 8.65%

This category consists of a variety of employee benefits including required contributions to the New York State Teachers' Retirement System and Employee Retirement System, Social Security, Workers' Compensation, Unemployment Insurance and Health Insurance benefits.

<u>Debt Service</u> 2,276,913 2,281,013 4,100 0.18%

This category contains District-wide costs associated with serial bonds for school construction

Capital Outlay Project

- ➤ The proposed budget includes \$100,000 for a capital outlay project.
- > The project includes flooring modifications in various elementary classrooms.
- New York State will reimburse 93% of the project costs in the following year.
- > This is part of our ongoing facilities improvement plan which continues to focus on and improve the educational environment for our children.
- ➤ Work will be scheduled in the summer of 2021.
